FEEDING DIRECTIONS

Feed to cattle, hogs, and horses. Do not feed additional salt or other mineral containing salt.

CATTLE: Feed free choice - 2 to 4 ounces per head per day. Pour in mineral feeders or bunks located in easy access areas, such as pathways or watering and loafing areas. Or, mix with rations.

HOGS: Feed free choice one ounce per head per day.

HORSES: Feed free choice 2 to 4 ounces per head per day.

NOTE: Animals deprived of mineral may over-consume *Super Ranger Kaydets* when first offered free choice. If this occurs, limit amount offered for first 7 to 14 days. Supply cattle or horses one pound per 5 head, hogs one pound per 10 head. If over-consumption continues, mix additional salt with *Super Ranger Kaydets*.

WARNING: This product, which contains added copper, should not be fed to sheep or related species that have a low tolerance to copper.
