Monocalcium Phosphate, Calcium Carbonate, Salt, Molasses Products, Processed Grain By-Products, Zinc Polysaccharide Complex, Manganese Polysaccharide Complex, Iron Proteinates, Cobalt Polysaccharide Complex, Ethylenediamine Dihydriodide, Zinc Oxide, Magnesium Oxide, Sulfur, Manganous Oxide, Vitamin A Supplement, Vitamin D3 Supplement, Vitamin E Supplement, Sodium Selenite, Iron Oxide, Vitamin B-12, Niacin, and Choline Chloride.

-FEEDING DIRECTIONS-

Feed to Cattle, Hogs, Sheep and Horses. Do not feed additional salt or other mineral containing salt.

CATTLE: Feed free choice - 2 to 4 ounces per head per day. Pour in mineral feeders or bunks located in easy access areas, such as pathways or watering and loafing areas. Or, mix with rations.

HOGS: mix with rations.

SHEEP: Feed free choice - one ounce per head per day.

HORSES: Feed free choice - 2 to 4 ounces per head per day.

NOTE: Animals deprived of mineral may over-consume Royal Mineral when first offered free choice. If this occurs, limit amount offered for first 7 to 14 days. Supply Cattle and Horses one pound per 5 head. If over-consumption continues, mix additional salt with Royal Mineral.

CAUTION: Follow label directions. Current regulations limit supplemental selenium intake to 3 milligrams per head per day. 4 ounces of this product will provide 3 milligrams per head per day. The addition to feed of higher levels of this product containing selenium is not permitted.
