CATTLE TOP DRESS: Feed so cattle receive 3 ounces per head per day.

CATTLE MIXING DIRECTIONS: Low moisture ration, mix 50 pounds of Kay Dee DCS Mineral per 2 ton of complete ration. High moisture ration, mix 25 pounds of Kay Dee DCS Mineral per 2 ton of complete ration.
