Livestock may go through an adaptation period when HI-EN-R-GY TUBS are first offered free choice. If over consumption occurs: 1) decrease number of tubs, 2) move tubs away from watering and loafing areas, 3) increase quantity and quality of roughage. If under consumption occurs reverse the procedure.

**BEEF OR DAIRY CATTLE:** Feed free choice 1 to 2 pounds per head per day.

**SUPPLY:** One tub for 35 to 40 head of cattle.
