FEEDING DIRECTIONS

Consumption of Stablemate Tubs will depend on: 1) quality and amount of roughage, 2) condition of livestock, 3) previous feeding programs, 4) location of tubs. Supply one tub for 1 to 10 head. Horses may go through an adaptation period when Stablemate Tubs are first offered free choice. If over consumption occurs: 1) decrease number of tubs, 2) move tubs away from watering and loafing areas, 3) increase quantity and quality of roughage. If under consumption occurs reverse the procedure.

MATURE HORSES: Feed free choice 1 to 2 pounds per head per day.

GROWING HORSES: Feed free choice 1/2 to 1 pound per head per day.
